- (2) Includes 5,070 shares acquired under the Michaels Stores, Inc. Amended and Restated 1997 Employees Stock Purchase Plan based on a plan statement issued by the plan administrator as of September 30, 2002.
- (3) The reported amount is held by a 401(k) Plan (the "Plan") stock fund assumed to be fully invested in Michaels Stores, Inc. common stock. The reported amount is based on a plan statement issued by the Plan administrator as of September 30, 2002 as an estimate of the total number of shares that would be available to the reporting person if such holdings were liquidated on that date.
- (4) Exercise of stock options pursuant to original grant to reporting person on July 28, 2000 of options to purchase 25,000 shares of Michaels Stores, Inc. common stock under the Michaels Stores, Inc. 1997 Stock Option Plan (which option grant consisted of the right to purchase 50,000 shares of common stock subsequent to the two-for-one stock split issued to stockholders of record as of the close of business on November 12, 2001), 33,333 of which are currently vested and 16,667 of which will vest on July 28, 2003.
