PRESS RELEASE

Milan, 29 March 2005 - In relation to press reports published today and last week regarding operations connected with Telecom Italia and TI Media, Telecom Italia states that it is studying a possible reorganization of the Group's internet activities but that it is still to be defined. Clearly, the modality, conditions and terms of eventual operations in this direction can only be communicated to the market, as the rules of corporate governance require, when the relevant company organs have reached a decision, and have been formerly called. It should be noted that the smooth functioning of the market is ensured by the distribution of specific and determined items of news which are sourced exclusively to company organs and which are communicated only when these bodies have reached their decisions. The Telecom Group will therefore refrain from commenting on future press speculation on the matter.

- the ability of the Telecom Italia Group to achieve cost-reduction targets in the time frame established or to continue the process of rationalizing its non-core assets;
- the impact of regulatory decisions and changes in the regulatory environment;
- the impact of the slowdown in Latin American economies and the slow recovery of economies generally on the international business of the Telecom Italia Group focused on Latin America and on its foreign investments and capital expenditures;
- the continuing impact of rapid changes in technologies;
- the impact of political and economic developments in Italy and other countries in which the Telecom Italia Group operates;
- the impact of fluctuations in currency exchange and interest rates;
- Telecom Italia's ability to continue the implementation of its 2002-2004 Industrial Plan, including the rationalization of its corporate structure and the disposition of Telecom Italia's interests in various companies;
- the ability of the Telecom Italia Group to successfully achieve its debt reduction targets;
