This Amendment No. 1 amends the statement on Schedule 13D, dated August 4, 2006 (the "Schedule 13D") in respect to the shares of common stock, par value \$0.01 per share (the "Common Stock"), of Republic Companies Group, Inc., a Delaware corporation (the "Company").

The Schedule 13D is hereby amended as follows:

**Item**

**5. Interest in Securities of the Issuer.**

The information contained in Items 5(a)-(c) and 5(e) of the Schedule 13D are hereby amended and reinstated in their entirety as follows:

(a)-(b) Each of the Reporting Persons beneficially owns no shares of Common Stock by virtue of the consummation of the Merger on December 7, 2006.

(c) Except as described in Item 6 hereto, none of the Reporting Persons and, to the best of each Reporting Persons' knowledge, none of the executive officers, directors or controlling persons of Greenhill & Co., Inc., Greenhill Capital Partners, LLC or GCP 2000 listed on Annex A has effected a transaction in shares of Common Stock during the past 60 days.

(e) As of the effective time of the Merger on December 7, 2006, the Reporting Persons ceased to be beneficial owners of more than five (5) percent of the Common Stock.

**6. Contracts, Arrangements, Understandings, or Relationships with Respect to Securities of the Issuer**

Item 6 of the Schedule 13D is hereby amended by adding the following at the end thereto:

On December 7, 2006, Merger Sub merged with and into the Company. As a result of the Merger, all shares of Common Stock (other than those shares owned by holders of Common Stock who properly perfected their appraisal rights under the Delaware General Corporation Law) were converted into the right to receive cash, without interest, in accordance with the Merger Agreement.
