PPL expects to receive approximately \$15,000 in cash proceeds (before giving effect to cash in lieu of fractional shares which PPL will pay to such holders) for the shares of common stock and will use these proceeds for general corporate purposes. Our common stock is traded on the New York Stock Exchange under the symbol PPL. On May 10, 2004, the last reported sale price of our common stock on the New York Stock Exchange was \$40.56 per share.
