EXPLANATORY NOTE

This Registration Statement relates to the registration of additional shares of Common Stock of the registrant to be issued pursuant to awards granted under the Willbros Group, Inc. 1996 Stock Plan (the "Plan"). The additional shares relate to the amendment to the Plan to increase the number of shares of Common Stock available for issuance under the Plan from 1,125,000 originally available for issuance under the Plan to 2,125,000 shares. The contents of the registrant's Registration Statement on Form S-8, Registration No. 333-18421, filed with the Securities and Exchange Commission on December 20, 1996 (the "Prior Registration Statement"), are hereby incorporated by reference. The Items below contain information required in this Registration Statement that was not included in the Prior Registration Statement.
