On January 19, 2006, EchoStar Communications Corporation announced that its subsidiary, EchoStar DBS Corporation, has elected to redeem all of its outstanding 9 1/8% Senior Notes due 2009. In accordance with the terms of the indenture governing the notes, the remaining principal amount of the notes of approximately \$442 million will be redeemed effective February 17, 2006, at a redemption price of 104.563% of the principal amount, for a total of approximately \$462 million. Interest on the notes will be paid through the February 17, 2006, redemption date.
